POLICYHOLDER To the driver and the owner of the vehicle as the policy holder. Annual renewable.

COVERAGE	Criminal defence	<ul style="list-style-type: none">• Legal defence in favour of the policyholder or authorized driver.• Lawyer and attorneys services.• Legal expenses as a result of the criminal procedure.• Professional fees expenses subjected to the limit established in conditions.• Policy particulars.
	Criminal defence extent	<ul style="list-style-type: none">• Defence spending in another driver authorized for the crime of omission of duty relief, gross negligence and driving under the influence of alcoholic beverages, drugs or narcotics.• Expenses of defence of any occupant in judicial procedures.• Expenses of defence of the younger sons of age of the policyholder driving without knowledge or authorization.• Defence expenses in procedures due to lack or crime for acts unrelated to the circulation.• Expenses of defence for damages produced by goods or transported objects are own or foreign.

	Claims for personal damages	<ul style="list-style-type: none">• Claim for personal injury of the driver and/or occupants against third persons in charge in traffic accident.
	Claims for material damages	<ul style="list-style-type: none">• Claim of the material damages opposite to third persons in charge.• Claim of the franchise in the case of insurance against damage to the vehicle.• Claim for damage to goods and personal items.• Claim of damage due to works, explosions, floods and fires.• Claim opposite to third, of the material damages suffered by the vehicle when it is guarded or deposit of third.
	Advance compensations	<ul style="list-style-type: none">• When conformity is obtained of the opposite insurance entity in writing of the payment of the indemnification and up to the limit concentrated on the particular conditions of the insurance policy.
	Survey	<ul style="list-style-type: none">• Expert's fees in cases of disagreement with the assessment of the damage done by the insurer contrary. And the amount of the repair exceeding 600 €.
	R.C supplemental defence	<ul style="list-style-type: none">• Defence of the R. C. in criminal proceedings against the insured in the cases of discovered, rejection or insolvency of the insurance of R. C. of the vehicle itself.• The fees of barrister and solicitor.• Legal costs of civil order.• Defence in civil suits in a traffic accident.
